Summary

I am a social and behavioral scientist in the field of public health. I study social processes across a number of behaviors that impact health, such as modern contraceptive use, intimate partner violence, Pre-Exposure Prophylaxis use, and tobacco consumption. My focus area is on the measurement, conceptualization, and influence of social norms on behavior across a variety of settings and contexts.

I focus on bridging health behavior theory with a range of rigorous quantitative statistical approaches. Currently, I am most interested in social network analysis methods to understand normative change and reference group topology, latent variable analysis methods for longitudinal data (traditional SEMs and latent growth models), Bayesian regression (especially using informative priors) and visualization, and meta-analytic methods.
